Eligibility: IATA / UFTAA Foundation Course (Curso Básico IATA / FUAUV, Cours d'Introduction IATA / FUAUV) students, having failed a **second** examination attempt for either one or both examination papers.

Important: An eligible student is required to re-sit the exam paper(s) failed during the Foundation course enrollment. You can choose to re-sit at either the March or September examination session. Both application form and full payment must be received by 14 December for the March session, 14 June for September. You must register and re-sit your Third Examination Attempt **within one year** of having failed your second examination attempt. Once registered, you **must** sit the first available session. Ensure that this application form, along with full payment, is **received** at IATA Montreal by the examination registration deadline corresponding to the exam session of your choice. If your application form and/or full payment are received late, you will be automatically registered to sit the examination scheduled for six months later, provided this is within the one year eligibility period.
